

Epidemiological declaration form

Data processing agreement clause provided in relation to the announcement of epidemics

I, the undersigned declare the following:

- 1) I have read and accept the provisions of the "ISSRNS 2022 Registration Regulations";
- 2) I am not subjected to quarantine or I am not subjected to sanitary supervision;
- 3) In the period of 14 days prior to the participation in the conference ISSRNS 2022 I have not had direct contact with the following:
 - a.a person, who had a positive test for SARS-COV-2 coronavirus, causing the contagious disease COVID-19;
 - b.a person subjected to quarantine or isolation due to the above-mentioned viral infection;
 - c.a person, who had visible symptoms of disease or was exposed to contact with an infected person:
- 4) During the past 14 days I have had no symptoms of disease, particularly increased body temperature, cough, or respiratory problems;

I hereby declare that in the event of a change of any of the particulars communicated under points 2 to 4.1 will not participate in the conference ISSRNS 2022 or I will bring an end to my participation.

Personal data shall be processed within 21 days after the closing of ISSRNS 2022 conference. After 21 days your data will be deleted from all databases. The provided personal data shall not be processed by automated means as well as they shall not be processed in the form of profiling.

Lam entitled to the following:

a) The right to access the content of the data; b) the right of rectification of data; c) the right to the erasure of data; d) the right to limit the processing of data; e) the right to object to the processing of data.

I also have the right to file a complaint to the supervisory authority.

Personal data shall not be transferred to a third country (outside the European Union or the European Economic Area) or to international organizations.
